



**BOROUGH OF EDGEWOOD
ORDINANCE 987**

AN ORDINANCE OF THE BOROUGH OF EDGEWOOD ESTABLISHING FINES, FEES, AND CHARGES

WHEREAS, the Borough of Edgewood (the "Borough") has previously enacted ordinances establishing fees, fines, and charges; and

WHEREAS, the Borough Council has examined those fees, fines, and charges; and

WHEREAS, the Borough Council desires to amend and re-establish these fees, fines, and charges,

NOW BE IT ORDAINED AND ENACTED by the Borough Council and **IT IS HEREBY ORDAINED AND ENACTED** by authority of the same:

Section 1 – Administrative Fees

Municipal Lien Letter	\$25.00
Occupancy Permit	\$30.00
NSF Check	\$35.00
Copy Fees	.50/page

Section 2 – Police Fees and Fines

(a) False alarm occurrences are accumulated and tracked, per structure, on a yearly basis from January 1st to December 31st. False alarm fees are assessed on a yearly basis from January 1st to December 31st.

Police Reports	\$15.00
Fingerprints	\$15.00
Records Check	\$15.00
Borough Parking Tickets	\$7.50 w/in 72 hours \$15.00 after 72 hours
False Alarms	1 st occurrence – no charge 2 nd occurrence - \$30.00 3 rd or higher occurrence - \$50.00 each occurrence

Section 3 – Peddler's permits Fees

(a) For the purposes of this ordinance, a peddler is defined as someone who is soliciting door-to-door for a for-profit commercial enterprise.

Per day	\$10.00 per person
Per week	\$25.00 per person
Per Month	\$100.00 per person

Section 4 – Parking Fees

Residential on-street 3-5 A.M. permit	\$36.00 per year
Borough Lot permit	\$60.00 per year
Non-Resident permit	\$120.00 per year
Commercial vehicle permit	\$120.00 per year
Recreational vehicle permit	\$240.00 per year

Section 5 – Construction and Zoning Related Fees

Sanitary Sewer tap	\$200.00 per unit
Street opening	\$125 + .60/ft.

Zoning Hearing Board appeal	\$250.00
Zoning Ordinance	\$35.00
Subdivision ordinance	\$35.00
Zoning Map	Copy Cost
Other maps	Copy Cost

Section 6 – Building Fees

Residential – New Construction	\$40.00 plus .17 per sq. foot of Gross Floor Area
Residential – Additions	\$40.00 plus .17 per sq. foot of Gross Floor Area
Residential – Alterations & repairs	1.25% of construction cost (minimum fee of \$40)
Residential utility & miscellaneous use groups	1.50% of construction cost (minimum fee of \$40)
Commercial – New Construction	\$60.00 plus .25 per sq. foot of Gross Floor Area
Commercial – Additions	\$60.00 plus .25 per sq. foot of Gross Floor Area
Commercial – Alterations	2.5% of construction cost (minimum fee of \$60)
Residential Demolition	\$125.00
Commercial Demolition	\$225.00
Signs	\$25.00 plus \$2.00 per sq. foot of sign area (minimum fee of \$40.00)

Section 7 - Mechanical Fees

(a) Mechanical fees are applicable for air conditioning, furnaces, hot water heaters, and supply lines to these appliances not applicable for a building permit.

First \$1,000 of installation costs or fraction thereof	\$40.00
Each additional \$1,000 or fraction thereof	\$10.00
Minimum Fee	\$40.00

Section 8 – Miscellaneous Fees

Mulch	\$40.00 per load
Amusement Device License	\$125.00

Section – 9. Any Ordinance, or any part of any Ordinance, in conflict herewith is hereby repealed to the extent of such conflict.
