Ms. Schaefer had a question regarding the Cargill, Inc. bill and Mr. Cecconi explained that the bill was voided and reissued.

## **COMMITTEE REPORTS**

## **GENERAL GOVERNMENT REPORT**

Ms. Gleba stated that the Committee met today to review bills and discuss the Tax Anticipation Note (TAN). She stated that Mr. Cecconi noted the best option. Ms. Gleba went on to say that there will be another meeting to look at the budget.

Ms. Schaefer stated that the budget was reviewed line by line from both a historical and actual perspective, making an effort to cut expenditures. She stated that the budget will be advertised this week.

DISCUSSION: None.

#### POLICE REPORT

Mayor Davin gave a review of the monthly report, stating that there are some addition errors for 2009, but that the remainder of the report seems to be in line. The Mayor stated that calls and revenues are down for the year.

Chief Payne reported to the Mayor that there has recently been someone getting into unlocked cars. She reported that Officer Libell observed an actor on Chestnut Street who looked like he was getting into a car and the person took off, but left his knapsack with his ID in the car. Also, Officer Libell got a good look at the actor.

The Mayor then discussed the Citizen's Police Academy, due to begin in February or March. She stated that the Library staff is interested in participating and said information will be placed in the newsletter. She mentioned that a theft ID program is being reviewed. The County has offered to sponsor the program, according to the Mayor.

Mayor Davin asked for a decision from Council concerning the testing for Sergeant, an item which was left over from the last Council. She said the County is asking will we be using their test.

DISCUSSION: Ms. Schaefer said that this topic will be assigned to Public Safety. She then asked the Mayor whether this was for two or one sergeant and the Mayor assumed that it was for one. Ms. Schaefer stated that the financial implications of two sergeants needed to be reviewed.

Mr. Hellett then highly recommended the Citizen's Police Academy to the audience. He stated that this is a good course.

Ms. Schaefer then asked Mr. Cecconi to make sure that the newsletter reported that residents should lock their car doors and should not keep their keys in the car.

## **PUBLIC SAFETY**

Mr. Hellett stated that the Committee did not meet.

DISCUSSION: None.

#### COMMUNITY DEVELOPMENT

Ms. Waldock said that the Committee did not meet, but will schedule a meeting.

#### **PUBLIC WORKS**

Mr. Bowers stated that he met with the Public Works employees last Friday and expressed gratitude with what they have done over the last few weeks.

According to Mr. Bowers, the Allegheny County Sanitary Authority will hold a public information meeting regarding the Environmental Protection Agency's Consent Decree and sewer overflows on January 20, 2010 at 10:00.

Mr. Wilson said that the Committee has not met, but that a meeting will be scheduled.

Mr. Hellett stated that the Committee did not meet, but a meeting will be held regarding personnel.

#### PENSION COMMITTEE

Mr. Bright stated that the Committee did not meet, but a meeting will be scheduled soon.

#### AD HOC

#### PORT AUTHORITY AGREEMENT COMMITTEE

Ms. Schaefer noted that the name of this group has been changed to Comprehensive Plan Committee since working with the eastern corridor involves Swissvale and Rankin. An email has been sent to people who might be interested in the Committee, according to Ms. Schaefer.

DISCUSSION: None.

#### EDGEWOOD PRIMARY SCHOOL

Ms. Schaefer stated that the Committee will now be known as the Intercouncil Committee, a group that works with sister and brother communities in the Woodland Hills School District regarding problems.

The President stated that Mr. Hellett will be the Council of Governments representative and Mr. Wilson will act as alternate.

DISCUSSION: None.

## PARCEL D COMMITTEE

Ms. Schaefer said that this will fall under Community Development.

DISCUSSION: None.

#### 3 RIVERS WET WEATHER DEMONSTRATION PROJECT

Ms. Schaefer stated that this group will meet quarterly and the meetings are usually the fourth Monday.

Regarding the Library Board, Ms. Schaefer noted that Ms. Waldock expressed interest in joining this group. The next meeting is January 28, 2010 at 7:00 PM. Ms. Schaefer noted that one more person from Council is needed for the Board.

DISCUSSION: None.

#### BOROUGH SOLICITOR REPORT

Mr. Barry reported that if the last three motions and advertisements of this meeting were done in compliance with Section 1011 of the Borough Code, it appears all is in order. He stated that Council would have to waive its own rules to the extent that February 1, 2010 is the passing date.

Regarding the approval of the occupancy permit from the Zoning Hearing meeting, Mr. Barry informed Council that this came as a variance before the Zoning Hearing Board as the section in question says that in the D-7 district you can have retail, including whatever Council approves.

As far as the exoneration goes, Mr. Barry explained to the new members of Council that this represented that the Tax Collector has done her due diligence and is no longer legally responsible for taxes from 2009.

Finally, Mr. Barry spoke about Edgewood Towne Centre and the Train Station preservation. He said that the lease with Port Authority runs through March 16, 2037. Mr. Barry stated that even though Council is not required to get bids, the former Council requested an RFP.

Mr. Barry said that when there are sealed bids, the job goes to the lowest bidder, but in this case, the most financially able group could be picked or negotiations might take place.

He said the proposed use will be evaluated. He said that the Borough has to make sure that it is not going against the lease. If this property becomes publicly owned and used, it would be placed on the tax rolls, according to Mr. Barry.

Ms. Schaefer explained that this will be referred to the General Government and Community Development Committees.

#### **BOROUGH MANAGER REPORT**

Ms. Schaefer mentioned a thank you letter from a neighbor for the Public Works Department taking care of her sidewalk.

Mr. Cecconi reported that the Train Station renovations are ready for a walk through to develop a punch list for completion of the project.

The Nine Mile Run Watershed Association is talking about doing a rain garden. Ms. Smith of the Association says this will work, but Mr. Cecconi noted that this will need further discussion.

The Borough Manager stated that he is working on health insurance costs.

Mr. Cecconi reported that the basketball program has 70-80 kids playing and the men's' program has started.

DISCUSSION: Mayor Davin asked if anything is being done with the baggage building at the Train Station and Mr. Cecconi responded that until a use is found for it, it will not be included in this project.

Ms. Schaefer, speaking about the Nine Mile Run rain garden, stated that the funding will come from a grant and the group is looking at the Three Rivers Wet Weather Demonstration Program to see if there is a company that might use this as a prototype for green paving.

## **NEW BUSINESS**

Ms. Waldock asked if a thank you was sent to the Boy Scouts for their donation. She further inquired about Eastern Area Prehospital Services report and asked for an explanation of their legend used in their report. The Mayor answered that these represented calls.

Mr. Hellett set a Public Safety Committee meeting for January 25, 2010 at 7:30 PM and a Personnel Committee meeting February 8 at 7:30 PM.

Mr. Bowers set a Public Works Committee meeting for January 25.

#### **COMMITTEE ACTION**

M-7 Ms. Waldock moved to approve the occupancy permit application for Philips Edison for the Fitness Center Health Club in the Edgewood Towne Centre as approved by the Zoning Hearing Board. Second by Mr. Bowers.

DISCUSSION: None.

Ms. Cecil, representative for Phillips Edison, gave background information on Planet Fit. The group will use 26,000 sq. ft. of the 62,000 sq. ft. available in the Busy Beaver location. There are 350 locations, 30 of which are in Pennsylvania. No operation has ever been closed, according to Ms. Cecil. Memberships are either \$10.00 or \$20.00 per month.

Ms. Waldock asked for an updated restriction list and upon the Mayor asking if we are open to restrictions, Ms. Cecil answered in the negative.

Ms. Schaefer shared her appreciation for the Zoning Hearing Board and said the Borough wants to make sure everything is done appropriately.

Mr. Cecconi explained that Council is not opposing the decision of the Zoning Hearing Board to grant the variance, and the ordinance is not being amended.

Ms. Waldock asked if a different gym comes in, would it be amending section "J" of the ordinance.

Ms. Cecil asked how this can be changed and Mr. Barry said that this could be amended and reviewed by Mr. Cecconi, who could arrange to have it advertised.

Ms. Waldock said this was created by commercial lease and is not the Borough's problem.

DISCUSSION: None.

Upon roll call vote, the following was recorded: Mr. Bright, Mr. Bowers, Ms. Waldock, Mr. Wilson, Ms. Gleba, Mr. Hellett, Ms. Schaefer voted yes. **Motion carried**.

Early redemption is permitted and this can be paid in its entirety or in part, according to Mr. Cecconi, and no fees are included. The bank will do all DCED filings. With Citizen's Bank, the rate was 2.5% and there was a \$250 document fee.
