# BOROUGH OF EDGEWOOD MINUTES OF THE COUNCIL MEETING HELD MAY 7, 2012

President Schaefer called the meeting of the Borough of Edgewood to order at 7:33 PM in the Municipal Building.

#### **ROLL CALL**

Upon roll call, the following responded: Mr. Bright, Dr. Wallace, Mr. Wainright, Mr. Wilson, Ms. Gleba, Mr. Fuller and Ms. Schaefer.

Mayor Cook, Solicitor Barry and Anna Evashavik, the Junior Councilperson, were also present.

#### **PLEDGE**

The Pledge of Allegiance was recited.

# **AUTHORIZATION TO PAY BILLS**

Ms. Gleba moved to authorize the payment of bills, for goods and services received by the Borough, having been reviewed and approved by the General Government Committee in the amount of \$56,768.10 from the General Fund and \$11,883.74 from the Sewer Fund for a total of \$68,651.84. Second by Mr. Wilson.
