BOROUGH OF EDGEWOOD MINUTES OF THE COUNCIL MEETING OF APRIL 17, 2017

President Schaefer called the meeting of the Borough of Edgewood to order at 7:34 pm in the Municipal Building.

ROLL CALL

Upon roll call, the following responded: Mr. Bright, Dr. Wallace, Mr. Wainright, Mr. Fuller and Ms. Schaefer. Dr. Petrolla arrived at 7:45 pm.

Mayor Cook and Solicitor Barry were also present.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

ITEMS FROM THE FLOOR

Erin Pierce - C.C. Mellor Library

Ms. Pierce introduced herself as the new director of the C.C. Mellor Library. She thanked Council for allowing her and the library to be a part of the community. Ms. Schaefer welcomed Ms. Pierce, and said that the Borough values its partnership with the C.C. Mellor Library, and thanked them for being such good neighbors.

Angel Lehrain - 325 Maple Avenue

Ms. Lehrain is the president of the Edgewood Foundation, and presented her 2016 annual report to Council. She said in 2017 the Foundation had purchased a new movie screen for the Borough, and would be purchasing a new pine tree for Light Up Edgewood Night.

Al Caruso -150 Gordon Street

Mr. Caruso spoke about the Edgewood Foundation's Newcomers' Reception, which would be held on May 18th at 6 pm at 300 Maple Avenue. 3 RIVERS WET WEATHER DEMONSTRATION PROJECT/CONNECT Ms. Schaefer said that 3 Rivers Wet Weather was helping to reconstitute a committee to look at governance issues on the ALCOSAN board of directors. The CONNECT Congress will be held on Thursday, April 20th at 4 pm at the Circuit Center.

SOLICITOR'S REPORT Mr. Barry had nothing to report.

BOROUGH MANAGER'S REPORT Ms. Bastianini reported that the train station had been treated for termites. She said the auditor general's office performed an audit of the Borough's 2016 liquid fuels funds and issues no findings and no errors. She said a meeting would take place this week to discuss rights of way for the TAP project, and that the LED lights the Borough applied to Duquesne Light for in May 2016 had been installed on Pennwood Avenue and Lincoln Avenue.
