## BOROUGH OF EDGEWOOD ALLEGHENY COUNTY RESOLUTION 2018-23

A Resolution of the Borough of Edgewood authorizing the filing on an application for funds with the Allegheny County Department of Economic Development.

**WHEREAS**, the Borough of Edgewood is desirous of obtaining funds from the ACED in the amount of \$46,875 under the Federal Housing and Community Development Act as amended.

**NOW**, **THEREFORE**, **BE IT RESOLVED**, that the Borough of Edgewood does hereby formally request a grant from the Allegheny County Department of Economic Development.

**BE IT FURTHER RESOLVED**, that the Borough of Edgewood does hereby designate Amanda Settelmaier as the official to file all applications, documents, and forms between the TCVCOG and the Allegheny County Department of Economic Development.

**BE IT FURTHER RESOLVED**, that the Borough of Edgewood will assure, where applicable, the provision of the full local share of the project costs.

**BE IT FURTHER RESOLVED**, that the Borough of Edgewood will assure, that the project will be awarded or under construction within 180 days after contractual execution.

Adopted on Monday, October 1, 2018 by the Borough of Edgewood.

DISCUSSION: Mr. Zahorchak explained that adopting this resolution is a requirement for receiving CDBG funds for the chair lift should our application be approved by Allegheny County Economic Development.

DISCUSSION: Mr. Zahorchak explained that this price increase resulted from the discovery of additional defects on the tower that weren't visible during initial inspection.

M-5 Dr. Petrolla moved to accept Change Order No.2 from Arch Masonry dated September 19, 2018 for \$4,750 in additional stabilization work of exterior masonry on the borough building hose tower. Seconded by Mr. Fuller.

DISCUSSION: Mr. Zahorchak explained that this request was to repoint red brick on the inside of the tower.

### **BUSINESS MEETING**

**VOLUNTEER FIRE DEPARTMENT** No report given.

<u>WATER COMPANY REPORT</u> Mr. Fuller said bill mailings have been outsourced to increase staff availability to help customers. The board decided to reallocate funds to boost pension funding. The website has been redesigned to make online bill payment easier.

**RECREATION REPORT** Mr. Zahorchak reported indoor basketball registration is starting soon. Our Thai Chi instructor is interested in doing a winter session. Lastly, Council may want to consider reconstituting a recreation board to help with our programs as popularity increases and responsibility grows. Jessica Kaushansky currently oversees most of the programming and works part time and a group of volunteers would help with organization and oversight.

<u>PLANNING COMMISSION</u> Mr. Zahorchak said Mr. Glass resigned from the commission at the end of September and a replacement will be sought. Ms. Schaefer said candidates should submit a letter of interest to the manager.

**COG REPORT** Mayor Wilson had left the public meeting due to illness.

**SOLICITOR'S REPORT** Mr. Barry was absent and Ms. Schempf had nothing to report.

<u>BOROUGH MANAGER'S REPORT</u> Mr. Zahorchak he is working with the engineers to update the Borough's storm water management ordinance by year's end. He will apply for micro grant through Allegheny County to offset costs. The hose tower work is progressing and the architect will be surveying the rest of the building for repairs.

NEW BUSINESS Mrs. Schaefer announced a Committee of the Whole meeting for Monday, October 8 2018 at 7pm.
