BOROUGH OF EDGEWOOD MINUTES OF THE COUNCIL MEETING OF JUNE 18, 2018

President Schaefer called the meeting of the Borough of Edgewood to order at 7:35 pm in the Municipal Building.

ROLL CALL

Upon roll call, the following responded: Mr. Bright, Mr. Wainright, Mr. O'Donnell, Dr. Petrolla, Mr. Fuller and Ms. Schaefer.

Mayor Wilson and Solicitor Barry were also present.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

ITEMS FROM THE FLOOR

Republic Services

Representatives from Republic Services discussed the service disruptions that occurred in Edgewood Borough after the Memorial Day holiday. He said this is typically the heaviest trash week of the year, and that their crews were not able to keep up with collections, which caused delays. Ms. Schaefer said she was disappointed in the lack of communication between Republic and the Borough about the delays, and asked that Borough officials be made aware of service delays so that we could inform residents.

Al Caruso -The Edgewood Foundation

Mr. Caruso reviewed the Foundation's annual report with Council. He discussed a new event, Summer Saturdays in the Park music series, and said the Foundation had four new board members this year.

Mr. Wainright moved to approve the minutes of the May 21, 2018 Public Hearing. Second by Mr. Fuller.

PERSONNEL Mr. Wainright called a personnel committee meeting for Wednesday June 20th at 6:30 pm.

PENSION Ms. Bastianini reported on the first quarter 2018 pension performance.

SOLICITOR'S REPORT Mr. Barry had nothing to report.

BOROUGH MANAGER'S REPORT Ms. Bastianini reported on a successful Movies in the Park on June 11th, and said the next movie would be Frozen, played on June 25th. She updated Council on conversations she has had with Wilkinsburg Borough and their engineer to discuss flood mitigation techniques for the Wilkinsburg line at Koenig Field. She said a survey crew from Wilkinsburg would be out in the field this week. Ms. Bastianini said she had a meeting scheduled with representatives from the Port Authority to discuss overflow parking at the Hamnett Park and Ride station.

NEW BUSINESS

Mayor Wilson lifted the parking ban from 3 am on July 4th through 5 am on July 5th.

COMMITTEE ACTION
