**ROLL CALL**

Upon roll call, the following responded: Mr. Bright, Mr. Fuller, Mr. Love, Dr. Petrolla, Ms. Yaney, and Mr. Wainright. Councilmember Ryan O'Donnell, Solicitor Tim Barry and Mayor Wilson were absent.

**PLEDGE**

The Pledge of Allegiance was recited.

**ITEMS FROM THE FLOOR:**

Ben Reynolds reported the fire department was ready to handle any COVID-19 calls and was available to answer any questions from council or borough staff at any time about the virus. Council thanked him for his service.

**M-1** Mr. Fuller moved to approve the meeting minutes February 18, 2020. Second by Mr. Love.

Upon roll call vote the following responded yes: Mr. Bright, Mr. Fuller, Mr. Love, Dr. Petrolla, Ms. Yaney, and Mr. Wainright. **Motion carried.**

**M-2** Mr. Love moved to approve the meeting minutes from March 2, 2020. Second by Dr. Petrolla

Upon roll call vote the following responded yes: Mr. Bright, Mr. Fuller, Mr. Love, Dr. Petrolla, Ms. Yaney, and Mr. Wainright. **Motion carried.**

**AUTHORIZATION TO PAY BILLS**

**M-3** Mr. Fuller moved to authorize the payment of bills, for goods and services received by the Borough, having been reviewed and approved by the General Government Committee, from the General Fund in the amount of \$65,257.20 and from the Sewer fund in the amount of \$168,392.06 for a total of \$233,649.26.

**M-4** Ms. Yaney moved to hire Charles Dill as a summer help employee in the department of public works at a rate of \$10.25 effective March 17, 2020. Second Dr. Petrolla

- M-5** Mr. Fuller moved to authorize the purchase of 2020 Ford Explorer Police Interceptor Utility Vehicle from Tri Star Ford in the amount of 45,006.30, including outfitting. Second Dr. Petrolla
