**MINUTES OF THE COUNCIL MEETING HELD MARCH 20, 2023**

Council President Petrolla called the meeting to order at 7:37pm.

**ROLL CALL**

Upon roll call, the following responded: Dr. Blasiolo, Dr. Epitropoulos, Mr. Love, Ms. Patel, Mr. Sherman, and Dr. Petrolla. Mayor O'Donnell, Junior Councilperson Kochupora, Solicitor McDermott, and Borough Manager Zahorchak were also present. Ms. Yaney was absent.

**PLEDGE**

The Pledge of Allegiance was recited.

**ITEMS FROM THE FLOOR:** The following public comments were received.

Beth Battaline, 150 Washington St: Ms. Battaline spoke concerning several items in the neighborhood.

**APPROVAL OF MINUTES**

**M-1** Mr. Love moved to approve the minutes of the February 21, 2023. Second by Dr. Epitropoulos.

DISCUSSION: None.

Upon roll call vote the following responded yes: Dr. Blasiolo, Dr. Epitropoulos, Mr. Love, Ms. Patel, Mr. Sherman, and Dr. Petrolla. **Motion carried.**

**M-2** Mr. Love moved to approve the minutes of the March 6, 2023 Council Meeting. Second by Dr. Epitropoulos.

**AUTHORIZATION TO PAY BILLS**

**M-3** Mr. Love moved to authorize the payment of bills for goods and services received by the borough from the General Fund in the amount of \$ 98,921.99 and from the Sewer Fund in the amount of \$190,342.79 for a total of \$289,264.78. Second by Dr. Epitropoulos.

DISCUSSION: Mr. Love stated that notable items included a sewer pass through to ALCOSAN and tree removal.

Upon roll call vote the following responded yes: Dr. Blasiolo, Dr. Epitropoulos, Mr. Love, Ms. Patel, Mr. Sherman, Ms. Yaney, and Dr. Petrolla. **Motion carried.**

**COMMITTEE REPORTS:**

**GENERAL GOVERNMENT:** Mr. Love reported that General Government met to discuss the resolutions included on the agenda.

**POLICE:** Mayor O'Donnell discussed a grant received from the state for some upcoming borough projects. Mr. Zahorchak noted that testing is in process for new police applicants.

**PUBLIC SAFETY AND INFRASTRUCTURE:** Ms. Yaney stated that Public Safety and Infrastructure did not meet.

**COMMUNITY AFFAIRS:** Mr. Sherman stated that Community Affairs met to discuss the Koenig Field resolution.

**PENSION AND PERSONNEL:** Dr. Blasiolo stated that Pension and Personnel did not meet.

**AD HOC COMMITTEES:** Ms. Patel stated that she attended a meeting for the Commission Against Violence where they discussed an upcoming Stop the Bleed training, happening March 27 at the Edgewood Club.

**SOLICITOR'S REPORT:** Mr. McDermott stated there was nothing to report, besides a brief Executive Session to happen following the meeting over a personnel matter, with no action to be taken.

**BOROUGH MANAGER'S REPORT:** Mr. Zahorchak reported that the police have a list of curb areas that need to be painted. Public Works is completing their annual catch basin inspection with cleaning and maintenance. Our engineer is working on the 2023 paving program, with a focus around Edgewood Ave. Locations are being chosen for line painting around the borough, and we are collaborating with Swissvale Borough to paint S. Braddock Ave. Street sweeping starts in April. He discussed a recent grant to be used for several different projects in the next year, including storm sewer work near Elmer St, Beech St, and Locust St. The Easter Egg Hunt will take place April 1.

**NEW BUSINESS** Mr. Zahorchak stated that televising work is being done on portions of the sewer system, via a grant through Three Rivers Wet Weather.

**COMMITTEE ACTION**
